



COOKIE POLICY

OF JOINT-STOCK COMPANY "RUSSIAN COPPER COMPANY"

1. GENERAL PROVISIONS

1.1. Cookie Policy of Joint Stock Company "Russian Copper Company" (hereinafter referred to as the "Policy") defines the procedure and conditions for the use of cookies by Joint Stock Company "Russian Copper Company" (hereinafter referred to as the "Company", "we") by users during their visit to and use of the website <https://rmk-group.ru/> (hereinafter referred to as the "Site").

1.2. The Policy clarifies the provisions of the Policy regarding personal data processing in the Joint Stock Company "Russian Copper Company" as posted on the Website.

2. WHAT ARE COOKIES?

2.1. Cookies are small files downloaded to the device (including a mobile phone, computer, tablet or other device) from which you access the Site. Cookies stored on your device are usually sent to the Site when you revisit it or to another Site that can recognize them.

2.2. Cookies allow us to identify you, obtain information about the actions you perform on our Site, as well as your preferences, thereby helping to make your visit to the Site more convenient.

2.3. We use the term "first-party cookies" for cookies that we set and configure ourselves, and the term "third-party cookies" for cookies that are set by other technology service providers. Third-party cookies enable third-party features or functionality (such as social media features and analytics) to be provided on or through the Site.

3. HOW TO MANAGE COOKIES?

3.1. You can manage cookies in various ways. Please note that if you delete or block cookies, you may not be able to access all of the Site functions or not all of the Site pages will be displayed correctly.

3.2. Most browsers allow cookies by default, but you can control whether cookies are accepted by using your browser controls, usually found in the "Tools" or "Preferences" menu of your browser.

3.3. In addition, you can adjust the settings of your browser used to view the Site to enable, disable or delete cookies. Detailed instructions on how to adjust your browser are published by browser companies and can be found here:

- Edge;
- Chrome; Chrome for iOS; Chrome for Android;
- Firefox; Firefox for iOS; Firefox for Android;
- Safari for macOS; Safari for iOS.

4. WHAT COOKIES DO WE USE?

4.1. We use cookies only on the basis of your consent. You can opt out of using cookies in the settings of your browser through which you access the Site, as well as in the settings of your device. The tables below indicate which cookies we use and what their purpose is.

4.2. *Strictly Necessary Cookies.*

Strictly necessary cookies are essential for the website to function and cannot be disabled in our systems. They are typically only activated in response to Your actions which amount to a request for services, such as setting your privacy preferences, logging in or filling in forms. You can set your browser to block or alert you about these cookies, but then some parts of the site will not work:

4.3. *Analytical cookies.*

Analytical cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors browse the site. All information collected by these cookies is aggregated and therefore anonymous. If you do not allow these cookies we will not know what you do on our site:
